How much Insulation with energex®?

The following detailed calculations demonstrate what can be achieved with the energex system. From this chart, you can determine the amount of insulation required.

It should be noted that **energex®** requires no changes in the building structure. No internal space is used. No additional work is required, and no significant weight is added. Significant benefits are realized in occupant comfort along with minimal upkeep. Other benefits include lowering initial investment in heating and cooling and in operating expenses.

Assumptions

8" Concrete = 8" actual 8" Block = 7 5/8" actual Lamina = 1/8" total Matrix @ Substrate = 1/8" Steel and Wood Studs = 3 5/8" 'Exterior Grade Gypsum Sheathing conforming to ASTM-C79.
